The conference fee includes, for one person: conference attendance, publication of one paper (the paper must be presented at the conference to be considered for publication), access to the events during the conference. In case of on-site attendance, the fee includes the meal and coffee breaks.

Please note that at least one author per accepted paper/ presentation must register and attend the conference for the paper to be published in the conference proceedings. Only the papers presented during the sessions will be published in the conference volume.

An author who submits more than one paper/ presentation (as single author or as a co-author with the same team of co-authors) needs to pay the supplementary paper/ presentation fee. If a person co-authors a paper/ presentation with a different team, then they need to pay the full fee for the second paper/ presentation as well. A person may submit as single author or co-author maximum two papers/ presentations.
